

ANTI-PLAGIARISM RULES

Art. I. Plagiarism

1. A student is obliged to respect the rules of academic ethics and practice in his/her field of study, project or work where his/her authorship is expected (hereinafter referred to as "student work").
2. A student commits plagiarism if he/she, even by negligence, uses the words, thoughts, concepts, schemes or the work of another person or from another source (hereafter referred to as the "work of another author") in his/her student work without attribution to that person or source.
3. Plagiarism is a serious offense against the rules of academic ethics.

Art. II. Responsibility of the student

1. A student is responsible for ensuring that his/her student work:
 - a) contains a full and true attribution to all sources, inspiration and works of other authors;
 - b) quotes or paraphrases in accordance with the rules of quotation and professional practice;
 - c) in no way presents the work of another author under the student's own name.

Art. III. Responsibility of the supervisor

1. A supervisor is responsible for ensuring that:
 - a) students are familiar with the rules of quotation and, if necessary, with other academic ethics rules and professional practices in working with the works of other authors
 - b) in the context of the examination and assessment of the student's work, the supervisor shall appropriately focus on whether the student has not committed plagiarism, including the use of the anti-plagiarism system, if it is expedient to do so,
 - c) in the case of detection of plagiarism, the supervisor proceeds in accordance with ARCHIP's rules.

Art. IV. Qualification thesis

1. The student is obliged to submit the text part of the diploma project (qualification thesis) also electronically in an editable format.

2. After submitting the diploma project, its text part will be checked against the anti-plagiarism system and the results of the examination will be attached to the diploma project so that the supervisor, reviewer, student and the chairman of the commission for state final examinations have access to it.

Art. V.**Detection of plagiarism**

1. An academic worker who, on the basis of his or her own findings or suggestions, suspects that a student has committed plagiarism shall notify the Vice-Rector of this fact.
2. If the Vice Rector concludes that the suspicion of plagiarism is justified, he/she decides to initiate disciplinary proceedings unless he/she concludes that the possible violation of the student's obligations can be adequately addressed in the assessment of the given student work.
3. A supervisor who finds that student work is in any part a plagiarism will take this fact into consideration in evaluation and grade the work as unsatisfactory.

Art. VI.**Dishonesty**

1. In the case of a student's dishonest behaviour, e.g. cheating during a written test, the tutor will draw the appropriate consequences in the assessment and award of the grade. In case of serious or repeated dishonest behaviour, the tutor informs the Vice-Rector who decides whether to initiate disciplinary proceedings.
